### *Practical Solutions for Complex Workplace Issues*

"Work is a significant part of peoples' lives," Jimmy says, adding that "issues in the workplace can, in many cases, be very personal, so it is important to approach them with empathy and compassion."

This was particularly important during the first year of the COVID-19 pandemic. "It truly was an unprecedented time with employers trying to navigate a very uncertain business climate while trying to comply with constantly evolving health and safety guidelines," he adds.
