Triple Threat: Tenacious, Tactical, Team Player

While a summer associate at Day Pitney, Andraya Pulaski Brunau's first hands-on legal experience was interviewing a pro bono client who was on death row. She had just completed a research memorandum for that case when the partner asked if she wanted to meet the client that afternoon. Andraya jumped at the opportunity.

"The client's past did not matter to me," Andraya says. "I was there to listen and help with a legal problem, and I knew that if I could find a way to get the client to trust me, it would be easier to get the client to discuss some of the more difficult topics." Her strategy worked. At the end of the interview, it was clear that her calm but persistent questioning had elicited key facts that would shape the overall strategy.

After graduating from Providence College, with a major in Mathematics and History, Andraya attended the University of Connecticut School of Law where she completed a semester-long internship at the Department of Justice. Following an appellate court clerkship, Andraya joined Day Pitney, where she has developed a diverse litigation practice that includes representing corporate and individual clients in intellectual property disputes, commercial and tort litigation, and complex probate matters.

We assembled a strong, diverse team of lawyers with different backgrounds and dug into every issue from every angle to best serve the client."

Andraya also applies creative thinking to prelitigation resolution, when it may be most favorable for a client. Her creative approach has resulted in the successful resolution of intellectual property and commercial disputes before trial, helping clients satisfy their business objectives while also protecting their legal rights.
