Cost-Effective

Pricing Options

Day Pitney GC Services are priced to encourage early and frequent access to legal advice on the core issues that face your management team, so that your Day Pitney GC can assist in evaluating opportunities and threats and in developing alternative strategic responses and tactical legal action plans.

Annual Fee: A fixed annual fee, payable monthly, covers all of your in-scope Day Pitney GC Services. Other fee structures are also available depending upon your needs.

Legal Needs Assessment: Your Day Pitney GC will typically conduct an initial legal needs assessment, following which, together with you, we determine the right scope of GC Services for your organization and appropriate annual fee. The scope of services and fee are then reviewed periodically with you to determine if a mutually-acceptable adjustment is appropriate.

Out-of-Scope Services

When your organization encounters non-routine legal challenges – such as an acquisition or merger, major asset divestiture, financings, fundamental financial or structural reorganization, sale of the business, or litigation – your Day Pitney GC, armed with an intimate knowledge of your organization, is ready to help you assemble the right team of financial, legal and other advisers to help you address and manage the challenge.

Arranging and Pricing Out-of-Scope Services: Your Day Pitney GC will help you evaluate and select the best option for you. If it makes sense, Day Pitney will provide the additional services (e.g., for acquisitions or litigation) at standard hourly rates or under an agreed-upon alternative fee arrangement that suits your needs and is designed to manage the related legal spend with as much certainty as possible in the circumstances.

Your Day Pitney GC may recommend using other counsel for transactions or litigation requiring specialized experience (e.g., import/export or customs matters), for routine legal functions that can be performed economically by others (e.g., most property tax appeals), or for situations in which jurisdictional familiarity is desirable (e.g., litigation in Texas, California or the United Kingdom). Your Day Pitney GC will help negotiate the fee arrangement with other counsel that is right for you and then manage the legal effort on your behalf.
